
Subject: - **IMPLEMENTATION OF THE COMMON LAW ISSUED BY THE HON'BLE HIGH COURT OF BALOCHISTAN IN C.P. NO. 1326/2022, DATED 13-11-2023.**


Please refer to the Judgment/ Common Law of the Hon'ble High Court of Balochistan in C.P. No. 1326/2022, dated 13-11-2023.

2. The Judgment/ Common Law of the Hon'ble High Court of Balochistan regarding strike, abandoning classes or creating any hurdle of whatsoever in the administrative works of the Public Sector Universities is as under:

"[T]he respondents associations are restrained from observing strikes, abandoning the classes or creating any hurdle of whatsoever nature in the administration work etc. In future, if any employee of the university or representative of any association, mentioned hereinabove, is found indulged in observance of strike or holding demonstrations/ sit-in or any illegal activity, he shall be guilty of misconduct and the Vice Chancellor is bound to immediately initiate departmental action/proceeding against the delinquent. In case of failure the Vice Chancellor or the relevant authority of University shall expose themselves for disciplinary as well as contempt proceedings. Petition is accordingly disposed of in the above terms. Copy of this judgment be sent to all the Vice Chancellors of Public Sector Universities of Balochistan for compliance and necessary action."

3. As per the instructions of the Hon'ble Court, the aforementioned Judgment/ Common Law of the Hon'ble High Court of Balochistan is hereby circulated among all teaching faculty and administrative staff of the University of Turbat for the compliance and necessary action, please.

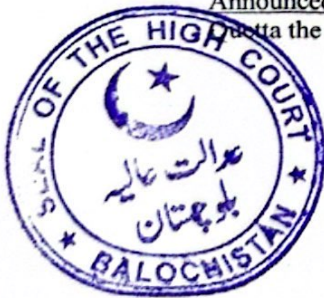
